**ABSTRAK**

Petugas rekam medis harus melakukan analisis kuantitatif tujuannya untuk menemukan kekurangan yang berkaitan dengan pencatatan rekam medis. Tujuan Penelitian ini yaitu untuk mengetahui angka persentase kelengkapan pengisian Catatan Perkembangan Pasien Terintegrasi (CPPT) rawat inap rekam medis elektronik di Rumah Sakit Umum Kuningan Medical Center.

Jenis penelitian ini menggunakan metode deskriptif kuantitatif. Objek penelitian yaitu Catatan Perkembangan Pasien Terintegrasi (CPPT) rawat inap rekam medis elektronik pada bulan Maret 2024 sebanyak 974 Catatan Perkembangan Pasien Terintegrasi (CPPT) rawat inap rekam medis elektronik. Pengambilan sampel dilakukan dengan cara *simple random sampling* sebanyak 91 Catatan Perkembangan Pasien Terintegrasi (CPPT) rawat inap rekam medis elektronik. Teknik pengumpulan data menggunakan metode observasi dengan instrument penelitian yang digunakan adalah lembar *checklist*.

hasil penelitian menunjukkan bahwa sebanyak 91 (100%) Catatan Perkembangan Pasien Terintegrasi (CPPT) rawat inap rekam medis elektronik tidak terisi lengkap. Dan Rumah Sakit Umum Kuningan Medical Center belum memenuhi Standar Pelayanan Minimal (SPM) yang ditentukan oleh Menteri Kesehatan Republik Indonesia Nomor 129 Tahun 2008 yaitu dalam hal kelengkapan pengisian rekam medis yang harus terisi 100% pada 24 jam setelah selesai pelayanan. Sehingga rumah sakit disarankan untuk evaluasi dan tinjauan secara berkala guna menjaga kepatuhan Profesional Pemberi Asuhan (PPA).

***ABSTRACT***

*Medical record officers must conduct a quantitative analysis in order to find deficiencies related to the recording of medical records. The purpose of this study was to determine the percentage number of completeness of filling in the Integrated Patient Progress Note (CPPT) inpatient electronic medical record at Kuningan Medical Center General Hospital.*

*This type of research uses quantitative descriptive methods. The object of research is the Integrated Patient Progress Note (CPPT) of electronic medical record inpatients in March 2024 as many as 974 Integrated Patient Progress Notes (CPPT) of electronic medical record inpatients. Sampling was carried out by means of simple random sampling as many as 91 Integrated Patient Progress Notes (CPPT) inpatient electronic medical records. The data collection technique used the observation method with the research instrument used was a checklist sheet.*

*The results showed that as many as 91 (100%) Integrated Patient Progress Notes (CPPT) inpatient electronic medical records were not completely filled in. And Kuningan Medical Center General Hospital has not met the Minimum Service Standards (MSS) determined by the Minister of Health of the Republic of Indonesia Number 129 of 2008, namely in terms of the completeness of filling out medical records which must be filled in 100% within 24 hours after completion of service. So that the hospital is recommended for regular evaluation and review to maintain compliance with the Professional Care Giver (PPA).*
